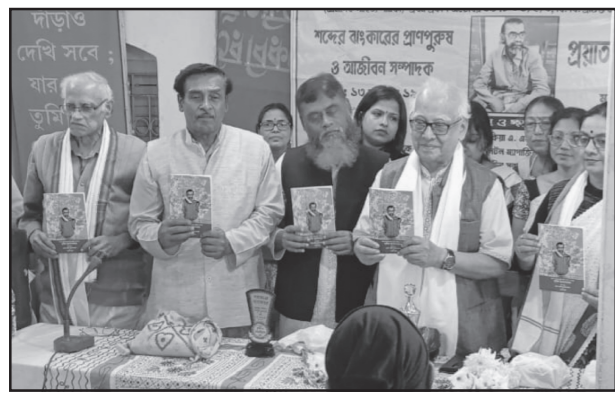

ED searches at multiple places in Bengal in 'embezzlement' of MGNREGA funds

KOLKATA, FEB 6 --/ The Enforcement Directorate (ED) on Tuesday morning started simultaneous searches at multiple places in West Bengal, including residences of some state officers, in connection with its investigation into alleged embezzlement of MGNREGA funds, officials said. The ED was conducting searches at the residence of a West Bengal Civil Services (WBCS) officer in Salt Lake's IA Block. He was earlier posted as a block development officer in Dhaniakhali in Hooghly district, they said. An ED officer said that he was not in his residence when they reached. "We are trying to locate him," he said. Searches were also underway at the government accommodation of a WBCS officer in Jhargram district, officials said. Besides the searches, he was being questioned by officers of the agency, they said. The ED was also conducting searches at the house and office of a

businessman at Chinsurah in Hooghly district, they said. Searches were also being conducted at a property linked to a state government employee in Baharampur in Murshidabad district. He was posted with the Panchayat Department, they added. (PTI)
